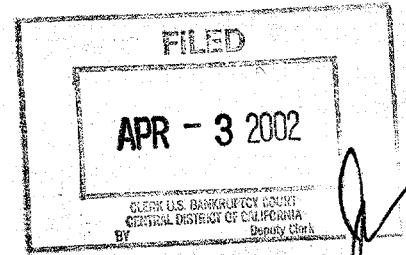

I, Richard Levine, declare:

10. I make this Declaration of my own personal knowledge, and if sworn as a witness I could testify competently thereto. This Declaration is filed in support of Non-Party Richard Levine's Reply to Opposition to Motion for Protective Order.

11. In my over 20 years of trading securities, I have developed considerable contacts and investment methodology and strategies. Over the last ten years my focus has been on trading initial public offerings, secondary offerings and follow-on stock offerings for the partnerships with which I have been involved. In doing such trades, I invested a great deal of time and expense in researching and investigating stock, in developing relationships with brokerage firms and other contacts and in developing an investment strategy. The documents I have produced to the Trustee and Creditor's Committee include trading records, my research and analysis, and extensive information about my contacts and business relationships with brokers. I have always maintained such information confidential because it reflects my investment methodology. In reviewing the trading records, my notes and analysis, one could be able to determine my investment strategies.
